Carol Tracy, Director of the Law Project said, "We are pleased that Nan has agreed to work with us to implement our strategic plan and to secure the resources necessary to implement it fully. Ms. Steketee most recently served as Bay Area Development Manager for Earth Share of California, a federation of environmental organizations raising money through workplace giving campaigns in that state. She was based in the San Francisco area for 6 years.

Nan is well acquainted with the public interest community in Philadelphia having served as Executive Director of the Center for Responsible Funding here in the city for 20 years through 2000. In that capacity she worked with civil rights organizations and anti-poverty organizations on increasing resources for program work.

She will be working with the board on their annual giving, a major gifts campaign, and donor briefings as well as overseeing all aspects of development and communications.
